I have read and understand the following partial, non-exclusive list of risks or incidents of which team member may or may not be subjected to, and I accept these risks, and other risks associated with my excursion which may not be listed, and I realize that One Moon Adventure Company cannot and will not assume responsibility for the injuries, illness or death which may be associated with these risks or incidents: insect bites and diseases spread by insect bites; snake bite; wild or domestic animal attack or bite; sunburn and heat exhaustion; hypothermia or hyperthermia, frostbite; trail hazards (falling, ankle-twisting, broken bones, cuts, etc.); altitude sickness, HACE or HAPE; water-borne illness; food-borne illness; airborne disease; allergens; robbery, attack or other molestation by 3rd party; exacerbation of existing condition or illness which may be difficult to treat on location and proper medical help may far away or non-existent; rock-fall, tree fall; hazards associated with automobile, train, airplane, horse-back, boat, canoe, bicycle or bus travel; drowning, falling; sudden illness, injury or death by any means.

Payment and reservation information:
One Moon Adventure Company, AKA "One Moon"

We strongly urge you to make your reservations as early as 3 months or more in advance, in order to be sure that you may have your trip and dates!

1. You will be required to sign a release form. This will be sent to you when One Moon receives your initial application. It must be returned to us no less than four weeks before your scheduled departure. No release-no trip. You will be asked to sign an optional photo release form.

2. Deposits - An initial deposit of \$500 must be received by One Moon to reserve your trip. This must be received no less than 30 days prior to departure. Again, we recommend 3 months or more in advance!

This is a non-refundable deposit if you should cancel your trip for any reason. If One Moon must cancel a trip for circumstances beyond our control, you will receive a full refund. Further details on application One Moon Adventure Company requires a minimum occupancy or persons per group, and reserves the right to cancel your trip due to lack of participation. You will be given the option of a refund or to travel at a later date or with another group.

3. Full payment is due 30 days prior to first day of travel, 100 % payment, refundable, should One Moon cancel your trip for any reason, non-refundable should *you* cancel for any reason. However, under some circumstances your deposit may not be refundable. Exceptions may be made for illness, death, other emergency, but is up to One Moon discretion.

3. To make an initial application without our application form, just email, telephone or mail the following information:

- A. Your full name and age
- B. Your address and telephone number.
- C. Name of trip you'd like to be on, i.e. "Inca Odyssey"
- D. Requested dates, and optional dates.
- E. Number of persons in your party.

One Moon will then contact you in regards to your deposit, vaccination requirements, release forms, travel documents, etc.

4. We accept major credit cards, personal checks, and other forms of payment. Credit card payment requires a 3% fee to be added to your cost.
